APA FUNDING UPDATE

After many phone calls, emails, trips to Juneau and meetings with our legislators, APA was included in the FY09 budget for \$250,000. This one-time appropriation was funded through the State's operating budget and staff and Board members are already working on getting APA included in the DHSS budget for FY10. The new DHSS Commissioner and Chief Medical Officer were duly impressed with the generosity you've contributed to APA since we opened our doors three years ago.

Providence Health & Services, Alaska reestablished their commitment to APA with a 3-year \$100,000 grant. We sincerely thank Providence for their ongoing support of our mission.

United Way of Anchorage recently allocated APA a \$25,000 grant for 2009. Funding will be used to supplement operating expenses for staff and patient benefits.

The Alaska Mental Health Trust Authority recently renewed their commitment to APA with a \$25,000 grant for 2009.

The Municipality of Anchorage appropriated \$25,000 for patient pharmacy benefits for the remainder of 2008 and \$75,000 for 2009 operating expenses.

Premiera Blue Cross of Alaska recently donated \$40,000 - \$20,000 for 2008 and \$20,000 for 2009. Their ongoing support is very much appreciated.

First National Bank Alaska donated \$2,500 towards 2008 operating expenses.

It is the goal of APA's Resource Development Committee to establish a network of local businesses to financially support our mission just as you so generously support us.

APA recently implemented a recognition program for volunteer providers—the prestigious Mt. Huntington Award. The inspiring story behind the award—APA received a large framed photo of Mt. Huntington as a gift from a grateful patient who received services in 2007. Mt. Huntington (elevation 12,240) is a steep rock and ice pyramid in the Alaska Range totally overshadowed by Mt. McKinley. This mountain represents to the patient the challenges that faced him while unemployed, uninsured and needing two hip replacements. The journey, while a steep climb, represents a successful summit with reclaimed health and employment. This award will be presented to three to four providers a quarter for their generous service to our medically uninsured neighbors.
